Mystery Mulligan Doubles Tournament

- 1. All bowlers must be USBC sanctioned and in good standing.
- 2. Enter as a Single bowler and get paired with a <u>random</u> partner.
- 3. Accepting walk-ins until **11:50 am**. Randomized pairing will begin after registration closes. Please turn in entry forms early.
- 4. Highest verifiable avg of 21+ games from 21/22, 22/23, or as of 4/30/24. **If no verifiable average, bowler will use a 230 scratch average.**
- 5. The Tournament committee reserves the right to rerate or adjust a bowler's average prior to posting of official results. Any adjusted or rerated averages, whether accepted or refused, must be reported. Failure to do so is grounds for disqualification.
- 6. Handicap per bowler will be 90% of 230 average.
- 7. Game with handicap pins cannot exceed 300.
- 8. The bowlers receive a combined 3 game series, each bowler being allowed to drop their lowest score from the 4 games bowled.
- 9. Any entrants, who have qualified for a cash and/or merchandise prize of \$600 or more in any tournament in final standings, brackets, side pots, all events, in the last 12 months must report their scores, positions and amount won to the tournament committee prior to bowling for possible re-rating. Failure to comply will be cause for forfeiture of entry fees and prize winnings.
- 10. Any conduct deemed inappropriate, foul language, obscene gestures, or abuse of facility equipment may be cause for removal from the competition as determined by the tournament committee (present board members).
- 11. All decisions made by the Tournament committee are final. This is defined by a majority vote of present Salinas USBC board members.
- 12. Any rules not covered by the above will revert to or be covered by USBC tournament rules. This is a USBC sanctioned tournament.
